**FELODROM ARFAETHEDIG RHUTHUN**

**Cyfathrebiad ffurfiol o'r ar gyfer rhanddeiliaid**

**Yn dilyn cyfarfod o'r Bwrdd Prosiect ar 7/06/22**

1. Mae datblygu Felodrom Gogledd Cymru yn Rhuthun bellach wedi cael ei gefnogi gan Chwaraeon Cymru, gyda grant o £2m wedi cael ei ddyfarnu i'r prosiect - y grant chwaraeon mwyaf yng Nghymru ers bron i 15 mlynedd. Mae'r grant yn cael ei ddal gan DLL, tra'n aros am benderfyniad ar y model cyflawni mwyaf priodol pe bai achos busnes y prosiect yn cael ei gymeradwyo i symud ymlaen.
2. Mae'r bwriad i greu trac awyr agored wedi bod dan ystyriaeth ers y deunaw mis diwethaf gyda gwaith dichonoldeb helaeth.
3. Mae cytundeb mewn egwyddor wedi ei gyrraedd hyd yma i greu canolfan ddatblygu yn Ysgol Brynhyfryd.
4. Mae Bwrdd Prosiect wedi'i sefydlu a chynhaliwyd ei gyfarfod cyntaf i fynd â'r cynllun a'r achos busnes cysylltiedig drwy broses gymeradwyo briodol y Cyngor ac i oruchwyllo'r dyluniad terfynol, yr ymgynghoriad cyhoeddus a'r camau cynllunio. Bydd y Bwrdd yn sicrhau bod holl fuddiannau rhanddeiliaid yn cael eu hystyried - CSDd, DLL, Cyngor Tref Rhuthun a Beicio Cymru.
5. Bydd briffiau rheolaidd yn cael eu dosbarthu i'r holl rhanddeiliaid trwy gydol camau nesaf y prosiect.

**PROPOSED RUTHIN VELODROME**

**Formal communications briefing for stakeholders  
following the inaugural meeting of the  
Project Board on 7/06/2022**

1. The development of a north Wales Velodrome in Ruthin has now been supported by Sport Wales, with the project being awarded a £2m grant - the largest sports grant in Wales for almost 15 years. The grant is being held by DLL, pending a decision on the most appropriate delivery model should the project business case be given the approval to proceed.
2. The proposal to create an outdoor track has been under consideration for the past eighteen months with extensive feasibility work.
3. In-principle agreement has so far been reached to create the development centre at Ysgol Brynhyfryd.
4. A Project Board has been established and had its first meeting to take the scheme and associated business case through the appropriate Council approvals process and to oversee the final design, public consultation and planning phases. The Board will ensure that all stakeholder interests are considered - DCC, DLL, Ruthin Town Council and Welsh Cycling.
5. Regular briefings will be circulated to all stakeholders throughout the next stages of the project.
